

TERMS AND CONDITIONS 1 MARCH TO 31 DECEMBER 2025

FREE 1-YEAR SINGLIFE HOME INSURANCE INCLUDING FAMILY CYBER RISK PROTECTOR BENEFIT FOR CIVIL SERVICE CLUB ("CSC") MEMBERS (THE "PROMOTION")

- 1. This Promotion for a free 1-year Home Insurance Policy including Family Cyber Risk Protector Benefit ("Free Insurance Policy") by Singapore Life Ltd. ("Singlife") is valid for any qualifying participant from 01 March 2025 until 31 December 2025 (both dates inclusive) (the "Promotion Period").
