

**TERMS AND CONDITIONS FOR
THE SINGLIFE DISABILITY SUPPORT PROGRAMME PROMOTION
(the “Promotion”)**

Campaign Period: 7 September 2022 and 31 December 2022 (both dates inclusive)

1. To receive the S\$10 Grab e-voucher (the “Gift”), only Qualifying Customers are eligible for the Promotion. To be a “Qualifying Customer”:
 - a) you must be a Singapore Citizen or a Permanent Resident who is aged 30 to 40 years old between 7 September 2022 to 31 December 2022 (both dates inclusive).
