**WHAT ARE YOU INVESTING IN?**

- You are investing in an ILP Sub-Fund that feeds 100% into the Underlying Fund, which is a sub-fund of Fidelity Funds, an open-ended investment company established in Luxembourg

<b>Market and Credit Risks</b>	
<p><b>You are exposed to Foreign Currency Risk.</b> The Underlying Fund’s NAV may be adversely affected by exchange rate fluctuations between the currency of denomination of assets/share class and the Base Currency, and changes in exchange rate controls.</p> <p><b>You are exposed to Equities Risk.</b> Investments in equities securities may sometimes fluctuate dramatically due to the activities and results of individual companies, or the general market and economic conditions or events.</p> <p><b>You are exposed to Country Concentration Risk.</b> The Underlying Fund’s concentrated investment in a single or small number of countries may increase its volatility due to the greater exposure to market, political, policy, foreign exchange, liquidity, tax, legal, regulatory, economic and social risks of those countries.</p>

**HOW OFTEN ARE VALUATIONS AVAILABLE?**

All ILP Sub-Funds will be priced based on the frequency of the fund manager’s pricing. The fund prices are updated daily and are available at Singapore Life Ltd.’s website at [www.singlife.com](http://www.singlife.com).

**HOW CAN YOU EXIT FROM THIS INVESTMENT AND WHAT ARE THE RISKS AND COSTS IN DOING SO?**

- You can exit the ILP Sub-Fund by submitting a request for withdrawal or fund switching (i.e. switches) to Singapore Life Ltd.
- If your Policy is newly incepted, you may cancel the Policy by giving us written notice of cancellation provided that such notice of cancellation is received by Singapore Life Ltd. at its Registered Office within the free-look period, which is fourteen (14) days from the date on which you receive the Policy.
- Upon cancellation of the Policy, Singapore Life Ltd. will refund the premiums you paid (without interest) after deducting the expenses incurred in issuing the Policy. The refund will be made after we receive the original Policy for cancellation.
- If there has been a decline in the market value, we will deduct the amount necessary to reflect the change in market value. If there has been an increase in the market value following the date Singapore Life Ltd. accepts your request to cancel the Policy, we will not pay you for such increase or any gain.
- For subsequent withdrawal/surrender or fund switching, transaction requests will need to be received and accepted by Singapore Life Ltd.:
  - (a) before 12 noon (Singapore time) on a Business Day will be processed according to the Unit Prices of the relevant Funds and the exchange rates (if applicable) prevailing on the next

appropriate Fund Valuation Date following the day Singapore Life Ltd. has accepted the request.

(b) after 12 noon (Singapore time) on a Business Day or on a non-business day will be considered as if received before 12 noon (Singapore time) on the following business day.

- The ILP Sub-Fund will have a single “dealing” price used for all switches and withdrawals/surrenders. There is no bid/offer spread.
- All ILP Sub-Funds will be priced based on the frequency of the fund manager’s pricing policy. As Units are cancelled using a forward price, the unit price for all switching and withdrawal of units will not be available at the time of receiving your application.

This cut-off time stated is correct as at the time of print. Singapore Life Ltd. reserves the right to change the cut-off time by giving you thirty (30) days’ prior notice or any such shorter period of notice as Singapore Life Ltd. may agree with the relevant authorities.

- The Withdrawal Amount you will receive as part of a subsequent withdrawal is illustrated as follows:  
For a partial withdrawal request of 1000 units of an investment-linked fund.
  - Assuming the unit price of the fund is S\$1.50:

The amount payable to the policyholder will be S\$1500, which is calculated as 1000 units x S\$1.50.

**APPENDIX: GLOSSARY OF TERMS**

<b>Base Currency:</b>	The base currency of the Underlying Fund.
<b>Business Day:</b>	A day on which the banks in Singapore and Luxembourg are normally open for business.
<b>FDIs:</b>	Financial Derivative Instruments.
<b>Fidelity Sustainable Family of Funds:</b>	A dedicated fund range exhibiting enhanced sustainable characteristics.
<b>NAV:</b>	As the case may be, the value of the assets less liabilities of the Fund, of the Underlying Fund, of a class of Shares or of a Share in the Underlying Fund determined in accordance with the "Net Asset Value and Swing Pricing" section of the Prospectus.
<b>Prospectus:</b>	Singapore Prospectus of Fidelity Funds.
<b>Share:</b>	A class of share of any one Underlying Fund in the capital of the Underlying Fund or a share in any such class.
<b>SICAV:</b>	société d’investissement à capital variable.
<b>Underlying Fund:</b>	Fidelity Funds – Sustainable Japan Equity A SGD

**Valuation Date:**

Each week day (any day Monday to Friday inclusive) excluding 25 December and 1 January as well as any other day which the Directors have determined, in the best interests of the Shareholders, as non-Valuation Dates. Non-Valuation Dates may for example be any day observed as a holiday on a stock exchange which is the principal market for a significant portion of the investments attributable to the Underlying Fund, or any day which is a holiday elsewhere so as to impede the calculation of fair market value of the investments attributable to the Underlying Fund, which may also include any day immediately preceding such relevant market closure where the dealing cut-off time of the Underlying Fund occurs at a time when the relevant underlying main market is already closed to trading and the following days are a period of consecutive market closure days. The list of expected non-Valuation Dates is available on <https://fidelityinternational.com/non-valuation-days/> and is updated in advance on a semi-annual basis. However, the list may be further updated from time to time in advance as is reasonably practicable in exceptional circumstances where the Directors believe that it is in the best interests of the Shareholders.
