WHAT ARE YOU INVESTING IN?

- You are investing in an ILP sub-fund that feeds 100% into an Underlying Fund, an openended collective investment scheme constituted in Luxembourg as a UCITS that aims to provide you with capital appreciation by investing in equity securities of small cap companies located in the Asia region.
- Under normal circumstances, you will receive regular distributions out of income
 depending on the distribution share classes you are investing in. Any distributions out of
 the capital of the Underlying Fund will reduce the NAV of the Underlying Fund.

 The Underlying Fund will invest primarily in equity securities of small cap companies registered under the laws of, or doing significant business in, Asia (excluding Japan). It may also invest, amongst others, in (i) participatory notes, or (ii) equity and debt securities of issuers worldwide. The Investment Manager also considers Environmental, Social and Governance (ESG) factors as an integral component of its fundamental investment research and decision process. The Environmental and/or Social characteristics (within the meaning of Article 8 SFDR) promoted by the Fund are detailed in the Appendix G of the Underlying Fund's Luxembourg Prospectus. The Underlying Fund may invest up to 20% of its net assets in aggregate in China A-Shares (through Shanghai-Hong Kong or Shenzhen-Hong Kong Stock Connect) and in China B-Shares. The Underlying Fund may further utilise financial derivative instruments for hedging and/or efficient portfolio management. These financial derivative instruments may be dealt in either on Regulated Markets or over-the-counter, and may include, inter alia, swaps, forwards and futures contracts (including those on equity indices) as well as options (including warrants). The expected level of exposure to securities lending transactions amounts to 5% of the Underlying Fund's net assets, subject to a maximum of 50%. You may be exposed to risks associated with small and mid-sized companies.

• The Underlying Fund may invest in small and mid-sized companies, which tend to have less liquidity and be more sensitive to changes in economic conditions and interest rates than larger, more recognized companies. As a result, the stock prices of small and mid-sized companies tend to fluctuate up and down more than those of larger companies.

You may be exposed to emerging markets risks.

 The Underlying Fund may invest in emerging markets which involve a greater risk of loss and are more volatile than investing in more developed countries due to, inter alia, greater political, tax, economic, foreign exchange, liquidity, volatility and regulatory risks.

The Underlying Fund will pay the following fees and charges to the Management Company, the Depositary and other parties:

Annual Management Charge 1.85% p.a. (a) Retained by Management Company (a) 52.5% to 100% of Annual Investment (b) Paid by Management Company to Management Fee financial adviser (b) 0% to 47.5% of Annual Investment distributor (trailer fee) Management Fee 0.01% to 0.14% p.a., or higher if the **Annual Depositary Fee*** Underlying Fund's investment objective and policy provides for investments in equity securities of issuers in developing countries. Annual Admin Fee Max 0.20% p.a. plus additional amount per Investor Holding over one year period and a fixed amount per year to cover part of its organisational expenses.

VALUATIONS AND EXITING FROM THIS INVESTMENT

- You can exit the ILP sub-fund by submitting a request for withdrawal or fund switching (i.e. switches) to Singapore Life Ltd.
- If your Policy is newly incepted, you may cancel the Policy by giving us written notice of cancellation provided that such notice of cancellation is received by Singapore Life Ltd. at its Registered Office within the free-look period, which is fourteen (14) days from the date on which you receive the Policy.

- Upon cancellation of the Policy, Singapore Life Ltd. will refund the premiums you paid (without interest) after deducting the expenses incurred in issuing the Policy. The refund will be made after we receive the original Policy for cancellation.
- If there has been a decline in the market value, we will deduct the amount necessary to reflect the change in market value. If there has been an increase in the market value following the date Singapore Life Ltd. accepts your request to cancel the Policy, we will not pay you for such increase or any gain.
- For subsequent withdrawal/surrender or fund switching, transaction requests will need to be received and accepted by Singapore Life Ltd.:
 - (a) before 12 noon (Singapore time) on a Business Day will be processed according to the Unit Prices of the relevant Funds and the exchange rates (if applicable) prevailing on the next appropriate Fund Valuation Date following the day Singapore Life Ltd. has accepted the request.
 - (b) after 12 noon (Singapore time) on a Business Day or on a non-business day will be considered as if received before 12 noon (Singapore time) on the following business day.
- The ILP sub-fund will have a single "dealing" price used for all switches and withdrawals/surrenders. There is no bid/offer spread.
- All ILP sub-funds will be priced based on the frequency of the fund manager's pricing policy. As Units are cancelled using a forward price, the unit price for all switching and withdrawal of units will not be available at the time of receiving your application. This cut-off time stated is correct as at the time of print. Singapore Life Ltd. reserves the right to change the cut-off time by giving you thirty (30) days' prior notice or any such shorter period of notice as Singapore Life Ltd. may agree with the relevant authorities.
- The Withdrawal Amount you will receive as part of a subsequent withdrawal is illustrated as follows:

For a partial withdrawal request of 1000 units of an investment-linked fund.

- Assuming the unit price of the fund is S\$1.50:

The amount payable to the policyholder will be S\$1500, which is calculated as 1000 units x S\$1.50.

APPENDIX: GLOSSARY OF TERMS

Dealing Day: means each day which is both a Valuation Day and a Singapore Business Day, or

otherwise as the Directors may from time to time determine.

NAV: means Net Asset Value.

Singapore Business Day: means a day (except Saturdays, Sundays and public holidays) on which commercial

banks are open for business in Singapore.

UCITS: means an undertaking for collective investment in transfer securities.

Underlying Fund: Franklin Templeton Investment Funds - Templeton Asian Smaller Companies Fund

Valuation Day: means any day on which the New York Stock Exchange (NYSE) is open or any full

day on which banks in Luxembourg are open for normal business (other than during

a suspension of normal dealing).
